ANNE MELLOR WILL TAKE ON FRANKENSTEIN

Anne Mellor is Distinguished Research Professor of English Literature and Women's Studies. At the Emeriti Association Winter Dinner on February 21, 2018, she will speak on "Mothering Monsters: Frankenstein and Genetic Engineering."

On June 16, 1816, Mary Shelley invented *the* myth of modern science, the myth of the scientist who creates a monster that destroys him and everyone he loves. How and why did this eighteen-year-old girl create this story? Professor Mellor's talk will explore the origins of *Frankenstein, Or The Modern Prometheus* (1818) in Shelley's personal experiences as well as in the scientific, political, and intellectual cultures of her day.

Professor Mellor will also explore what Shelley's novel has to tell us about recent technological developments in microbiology and genetic engineering.

Professor Mellor's scholarly interests focus on eighteenth- and nineteenth-century British literature, women's writing, feminist theory, and the visual arts. Her most recent book is *Mothers of the Nation – Women's Political Writing in England, 1780-1830.*

She has received numerous honors, including two Guggenheim Fellowships and the UCLA Distinguished Teaching Award.

This Winter Dinner Meeting will be held on February 21, 2018, in the Faculty Center Dining Room. The reception will begin at 4:45 p.m.

April 12, 2018 Our Mediterranean Heritage in Landscaping and Wine

Phillip W. Rundel, Distinguished Professor Emeritus of Ecology & Evolutionary Biology & Director of the UCLA Botanical Garden.

The plant palette for our landscaping and the varieties of wine that we drink in Southern California have their origins in the Mediterranean Basin. not yet be breaking bread together, at least they are not breaking limbs. I am confident that the negotiations, differences notwithstanding, will bear fruit. The administration needs the Faculty Center for its role in social interaction on campus and the Faculty Center needs administration's support. The Emeriti Association needs an attractive and healthy Faculty Center for its importance to us and its members.

At the most recent **CUCEA** (Council of University of California Emeriti Associations) meeting representatives of the Office of the President (OP) presented the current thoughts about retiree (including emeriti) health programs and costs. There will be no change in the 70% university contribution for 2018. Our **costs will rise** because the total cost of the supplemental health plans will rise. The program going forward will be guided by a broadly representative committee of the various constituencies which is charged with recommending benefits, any changes in benefits and a way of addressing the needs of both the administration and the retirees to reduce the monthly health care costs. This is vague because the outcome of these deliberations has not been determined. The first exchange program, now in place for out of state retirees and which limits the university contribution to \$3,000 per retiree or family member is working well and average usage to buy supplementary insurance falls below this amount. They have not ruled out a similar program for in-state retirees, but that is on the back-burner.

The Emeriti Survey promoted by CUCEA and documenting the contributions of emeriti to the university has made a great impact on administrations system wide. This resulted in the document that (*A Virtual Eleventh Campus*) implied that the emeriti contributions were the equivalent of one entire UC campus, dubbed brilliantly by John Vohs of UC Davis as the 11th campus. Plans are afoot for the 2018 iteration. UCLA participation was <u>not</u> good for the 2015 survey and we will be working with you to do better this time.

In closing, I want to welcome you to the New Year and encourage you to take advantage of this fabulous organization that is working for you.

A special guest at this event was past Director of the ERRC Eddie Murphy who travelled all the way from Ohio to attend the celebration.

Chancellor Emeritus Charles E. Young was also invited as a special guest but was unable to attend. An article about his Emeriti Association Lifetime Achievement Award can be found on Page 5.

Chancellor Young was instrumental in promoting the establishment of the UCLA Emeriti Association. Chancellor Young at the time was vice chancellor for administration and acted as chancellor because Chancellor Murphy was away from the campus. Chancellor Young's letter to the new Emeriti Board indicating "I am delighted--as I know the Chancellor will be --to learn of the formation of the Emeriti Association. The purposes of the Association as set forth are both worthy and realistic, and it should be a valuable addition to campus activities." Further, he also indicated "You may incorporate 'UCLA' into the title of the organization." He concluded his response by indicating "If there is any way that this office can be of assistance, please feel no hesitation in calling on us."

As then-archivist Norah Jones explained in the Spring 2002 report she wrote for the newsletter on the occasion of the association's 35th anniversary, the record indicates the development of the UCLA Emeriti Association was achieved over "A remarkable eight months, all in all, from November 7, to June 29, 1967. We'd be hard pressed to replicate such an achievement today."

Attendees received a copy of the report. The list of founders included such names recognizable on campus today as Helen Boelter, Vern Knudsen, Louis Slichter, Stafford Warren, and William Young. There were an additional 21 founders who have not (yet) had buildings named after them.

It was appropriate that the after-dinner presentation also involved health: "The Healthy Campus Initiative (HCI): Setting the Path for a Lifetime of well-being and Longevity." There are two leaders involved in this initiative, Professor Emeritus Michael S. Goldstein (Public Health) and Wendelin (Wendy) M. Slusser, M.D. Associate Vice Provost and Clinical Professor in Pediatrics and Public Health.

The HCI has brought many innovative changes to UCLA and the UC system by connecting stakeholders from many disciplines to make UCLA "The Healthiest Campus in America." HCI originally included four areas of emphasis: food and nutrition, mental health, exercise and physical fitness and the built environment on campus. HCI has since fostered the development of new academic programs such as a Food Studies Minor and a Graduate Certificate Program in Food Studies.

NEWS AND NOTES

Kudos, new undertakings, recent publications, and other reports from the far reaches of the world of UCLA emeriti.

Dr. Richard Ehrlich, urology professor emeritus, is a surgeon and a photographer. He has had his Holocaust Archives Portfolio accepted into the permanent collection of the J. Paul Getty Museum and presented "A Family Story of Autism" at the UCLA Conference on Art, Neuroscience, and Psychiatry. His photographs are featured in 19 museums around the world, including the permanent collections of the Smithsonian National Museum of American History, the Los Angeles County Museum of Art, the UCLA Hammer Museum, and George Eastman House. The UCLA library collections also have some of his work.

One recent project—Face the Music (a photographic series that captures the emotions of 40 famous musical artists listening to the music of their choosing)—has been published by Steidl. From a range of genres—including Quincy Jones, Ringo Starr, Herbie Hancock, Dave Brubeck, Wayne Shorter, Iggy Pop, Esperanza Spalding, Herb Alpert, Sir Graham Nash, Philip Glass, Jean-Yves Thibaudet and Emmylou Harris—they were photographed while listening to three pieces of music of their choice. With only two exceptions, they chose the music of other musicians rather than their own.

Dr. Ehrlich also helped to design the art program for the Luskin Conference Center, which showcases a number of his works.

Dr. Joaquin Fuster, senate emeritus distinguished professor in psychiatry and biobehavioral sciences, was one of three UCLA faculty selected as 2017 fellows of the American Association for the Advancement of Science. Members are awarded this honor by the AAAS for their scientifically or socially distinguished efforts to advance science or its applications. Fuster was being honored for his contributions to cognitive neuroscience.

Judea Pearl, emeritus professor of computer science and statistics, received the American Mathematical Society's 2018 Ulf Grenander Prize in Stochastic Theory and Modeling for the invention of a model-based approach to probabilistic and causal reasoning, the discovery of innovative tools for inferring these models from observations and for the development of new computational methods for the practical applications of these models.

Pearl said he viewed this prize in the context of a

philosophical puzzle that has haunted him for years: Why has science deprived cause-effect relationships of the benefit of mathematical analysis?

"My college professors could not write down an equation to express the most obvious causal statement. For example, that the rooster crow does not cause the sun to rise, or that the falling barometer does not cause the incoming storm," Pearl said. "Unlike the rules of geometry, mechanics, optics, or probability, the rules of cause and effect have not been encoded in a mathematical framework. Why have scientists allowed these rules to languish in bare intuition, deprived of mathematical tools that have enabled other branches of science to flourish and mature?"

Donald Shoup, distinguished research professor of urban planning at the UCLA Luskin School of Public Affairs, is the 2017 recipient of the Distinguished Educator Award—the highest honor bestowed by the Association of Collegiate Schools of Planning.

The award is conferred every two years to honor significant contributions to the field of planning, and it recognizes scholarly contributions, teaching excellence, public service and contributions that have made a significant difference to planning scholarship, education and practice. Shoup is the second current member of the UCLA urban planning faculty to win this award; Professor emeritus **Martin Wachs** won in 2006 when he was at UC Berkeley.

Professor Shoup is known as internationally renowned guru of parking. *The High Cost of Free Parking*, Shoup's widely acclaimed book (originally published in 2005, and revised and reprinted in 2011), was based on decades of research on parking policies. It also was based on years of listening.

Shoup said the latest award is particularly gratifying because it's for education. "Universities reward you mainly for research and publication. It's why we say, 'Publish or perish.' And I think most academics believe their lasting contribution will be their research," he said. "But I think that our most important contribution is through teaching. If we have any influence — if there is going to be anything to remember after we are gone — I think it will be through the successful careers of our students who will be changing the world for the better."

FACULTY CENTER MOVING FORWARD

The Faculty Center Association **membership** met November 30, 2017, led by Faculty Center Board President Belinda Tucker. Two topics were discussed: plans to restore fiscal solvency to the Faculty Center, and the state of negotiations with the UCLA Administration.

Good progress has already been made financially as first quarter (July, August, September) income was slighty positive compared with a loss of over \$100,000 last year in the same quarter. Much of this improvement was achieved by employee hours curtailment. In the Q&A session several members praised FC employees and showed concern that their hours had been reduced.

Negotiations with the administration are continuing with an agreement of two key provisions. The Faculty Center Association through the Faculty Center Board will retain control, and the Faculty Center Board will expand by two members appointed by the administration. Most members present at the meeting appeared to welcome these provisions.

Vice Chancllor **Steve Olsen** was introduced by Belinda Tucker and he made several comments. It seems possible that **an agreement** could be completed and put to a vote of the Faculty Center Association membership by March 2018.

LIFETIME ACHIEVEMENT AWARD TO CHARLES E. YOUNG

At our 50th Anniversary Celebration the Emeriti Association gave Chancellor Emeritus Chuck Young a lifetime achievement award. Young could not be there to accept the award, but his gracious note was read at the event.

After a cruise on the St. Lawrence and down the East Coast of the U.S., Chuck and Judy Young arrived home "during the horrendous firestorm which nearly devastated the area around our lovely town of Sonoma." This had caused a delay in their receiving the Emeriti Association's invitation letter.

Chancellor Young has undertaken his 5th post retirement position. He "assumed the job as interim Superintendent of the Sonoma Valley Unified School District." As he reports, "the normal difficulties of catching up on my return from a two week absence has been made nearly impossible by the added problem of getting the schools re-opened after two weeks in which all of them suffered the after effects of the fire, and some had served as evacuation centers for the many displaced citizens of our community."

Steve Cederbaum, caught up with Young at a visit to

UCLA on November 30, 2017, and presented him with the award, commemorated with a beautiful framed certificate.

Chancellor Young expressed his deep appreciation for the recognition, especially meaningful coming from us, who were part of his much heralded incumbency at UCLA. The Lifetime Achievement Award may not be made every year but is presented when a deserving candidate has been nominated. Deadline for the Emeritus of the Year and Lifetime Achievement Award is March 9, 2018.

EMERITI ABROAD

Last fall, the mailing that goes to all those eligible for membership in the UCLA Emeriti Association was sent to over 1600 people. Of those, 34 were posted to international addresses: There were four in Switzerland and the United Kingdom; three in England, France, and Israel; two in Canada, Denmark, Italy, and The Netherlands; and one each in Brazil, Chile, Japan, New Zealand, Scotland, South Africa, Sweden, Thailand, and the United Arab Emirates.

At 10,164 miles from Los Angeles (and 20 and a half hours flying time), South Africa would seem to take the prize for greatest distance. Of current members, the two who receive mail in Switzerland would be the most distant (at least at the time that the mailing labels were run).
