ZEV YAROSLAVSKY WILL SPEAK AT SPRING DINNER

After a 40 year career in Los Angeles city and county government, **Zav Yaroslavsky** retired from the County Board of Supervisors in 2014. He will be our guest at the Emeriti Association Spring dinner program and business meeting speaking on the topic "Zev Yaroslavsky: The View from 40 Years in Los Angeles Politics"

He was first elected to public office only two years after finishing graduate school at UCLA with an M.A. in history. After 20 years on the Los Angeles City Council, Yaroslavsky became supervisor for the Third District.

With more than 2 million constituents, the Third District is the most economically, ethnically and geographically diverse of Los Angeles County's five electoral districts and includes UCLA

Over his career, Yaroslavsky has been known for dealing with such issues and concerns as land use and the environment, the LAPD, bakery prices, transportation, and arts and culture.

At the opening performance of the Los Angeles Opera's 2014-15 season, Yaroslavsky was greeted by an enthusiastic audience when he conducted the national anthem.

In an interview with Patt Morrison published in *the Los Angeles Times* (December 2, 2014) as Yaroslavsky was leaving office, he saw his upcoming retirement this way:

"What is your list for post-public life?"

"I don't know yet. Maybe I'll go back to playing poker, as I did in college, supplementing my income! When I was first elected, a high school classmate wrote me a letter and addressed it to 'the Honorable Zev Yaroslavsky — dear Honorable Yaroslavsky: I knew you when you were not honorable.' I'm leaving on my own terms, but I will no longer be 'the honorable Zev Yaroslavsky.""

At the May dinner meeting we'll be able to find out what the no-longer honorable Zev Yaroslavsky has been doing. According to the Amy Sewell in the *Los Angeles Times* on April 6, 2016, Yaroslavsky is "now director of the Los Angeles Initiative at the [Luskin] school of public affairs."

The evening will also include the Emeriti Association's annual business meeting. The business meeting will include presentation of the Association's awards, voting on a proposed change to the constitution, and election of officers.

The Spring Dinner Meeting will be held Wednesday, May 11, 2016, in the California Room of the Faculty Center. The reception will begin at 4:45 p.m. Presentation of the Panunzio, Dickson, and Goldberg Awards will be made at 5:15 p.m. Dinner begins at 6:00 p.m. The Emeriti Association business meeting will take place after dinner and the program at 7:00 p.m.

UCLA history professor James L. Gelvin will speak on the topic "Syria, ISIS, and the Future of the Middle East" at the joint EA/ UCLARA after-lunch program on June 9, 2016.

Gelvin is a scholar of Middle Eastern history and has written extensively on the history of the modern Middle East, with particular emphasis on nationalism and the social and cultural history of the region.

Gelvin earned his B.A. from Columbia University in 1983, M.A. from the School of International and Public Affairs of Columbia University in 1985, and Ph.D. from Harvard University in 1992. Before joining the faculty at UCLA, Gelvin taught at the Massachusetts Institute of Technology (MIT), Boston College, and Harvard University.

He has been a fellow at the Woodrow Wilson International Center for Scholars (1999–2000) and the recipient of a U.C. President's Fellowship in the Humanities (1999–2000). In 2002-2003, he was Sheikh Zayed bin Sultan Al Nahyan Visiting Professor of History at the American University in Beirut.

In 2015, the Middle East Studies Association honored Gelvin with its Undergraduate Teaching Award, citing his "outstanding commitment to the practice and substance of undergraduate teaching, through his classroom performance, his training of future generations of undergraduate teachers, and his well-received undergraduate text-books. ... James Gelvin's accomplishments as a teacher and the teaching materials he has produced for others exemplify the kind of undergraduate teacher this award is meant to recognize."

Gelvin also received the Faculty Excellence Award, presented by the UCLA chapter of Mortar Board National Senior Honor Society in 1998.

His latest book is the second edition of *The Arab Uprisings: What Everyone Needs to Know* (Oxford University Press, 2015; first edition, 2012). His other books include *Global Muslims in the Age of Steam and Print, 1850-1930* (University of California Press, 2013, as co-editor) and *Israel Palestine Conflict: One Hundred Years of War* (Cambridge University Press, September 2005; 2nd Edition, 2007).

Gelvin has also published many articles and book chapters and appeared in numerous podcasts, videocasts, online and television interviews and commentaries as well as doing many other invited presentations.

CUCEA MEETS AT UCLA APRIL 25-26, 2016

Twice yearly, the Council of University of California Emeriti Associations (CUCEA) and the Council of University of California Retiree Associations (CUCRA) meet to provide representatives from each of the campus chapters the opportunity to discuss issues of common interest and to share ideas. Dan Mitchell is our CUCEA representative for UCLA.

This year, the UCLA Emeriti Association (EA) is assisting with host-

ing the spring joint CUCEA/CUCRA conference at UCLA on April 25 and 26. The dates of the conference were chosen in order to have UC President Napolitano meet with us at a joint CUCEA/CUCRA session.

One of the highlights to showcase UCLA will be a tour of The Center for Advanced Surgical and Interventional Technology (CASIT). CASIT is the hub of an interdisciplinary network of researchers, clinicians, teaching faculty and engineers from many UCLA schools and departments.

With major support from Emeriti and Retirees Relations Office (ERRC) staff, Rod Rose, President of CUCRA and John Dahl, Interim Director of the ERRC joined EA President Betty Chang to invite CUCEA/CUCRA representatives and guest speakers to our beautiful UCLA. John Dahl has been the primary person working on the conference. Dan Mitchell will report on the CUCEA/CUCEA meeting to our EA membership.

NEW GROUP FOR CAREGIVERS

After a somewhat hesitant start, the Cognitive **Decline/Dementia** Caregiver Support Group has become a reality. The group is intended to serve as a resource for those emeriti or their spouses/ partners who are dealing with issues of cognitive decline in their spouses/partners. The premises for organizing this group are (1) that emeriti/spouses/partners in the academic milieu are likely to have some issues that are unique to them and (2) that caregivers from a similar background will be better able to understand and support one another.

We are fortunate to have secured

the leadership of Karen Miotto, M.D., a UCLA psychiatrist, as facilitator. She will be ably assisted by Rebecca Wilkinson, MSPH, both of whom are responsible for mental well-being across the medical school and medical center.

The caregiver support group will meet from 1:00-2:30 p.m. on the first and third Tuesdays of each month, beginning April 19; meetings will be held in the conference room in 1116 Rolfe Hall.

SURVEY OF FACULTY ACTIVITIES

It was asserted at a recent Emeriti Association board meeting by a long-time UC watcher that emeriti contribute more to the University of California budget than the state of California does. Could that possibly be true? There may be some documentation on the emeriti contribution side, however.

The results of the survey of faculty activities (long known as the biobibliographic survey) from July 1, 2012, through June 30, 2015 conducted by the Council of University of California Emeriti Associations (CUCEA) has been reported by John Vohs, survey Co-chair, UC Davis. Barbara Sinclair died March 11, 2016, at the age of 76.

Members of the UCLA Emeriti Association board are saddened by the passing of our colleague. Barbara had recently resigned her position as a member-at-large and member of the program committee. miss her quiet presence at board meetings.

Barbara came to UCLA after 25 years at UC Riverside to become the Marvin Hoffenberg Professor of American Politics in 1996. Gregory Koger, writing in The Washington Post, called her "a renowned congressional expert who contributed as both a researcher and a public intellectual." He said, "Over the course of a renowned career, she explained the inner workings of congressional party leaders, the evolution of the Senate, and the ability of Congress to enact major legislation."

The University flag is scheduled to be flown at half-staff in Barbara's honor on Thursday, May 5, 2016. The flag is located between Paulev Pavilion and the James West Alumni Center.

EMERITI EXPRESS

Kudos, new undertakings, recent publications, and other reports from the far reaches of the world of UCLA emeriti.

Robert Bjork, psychology professor emeritus and distinguished research professor in the field of cognitive psychology, delivered the spring 2016 Faculty Research Lecture on February 17. "How We Learn Versus How We Think We Learn" is now available on video at the Faculty Research Lecture Archives < http://www.oid.ucla.edu/Webcast/FRL>. The twice yearly lectures showcase the work of UCLA's most distinguished scholars and were established by the Academic Senate in 1925.

Distinguished Professor of Psychiatry Emeritus **Robert Paul Liberman** reports that since retiring 10 years ago, he has continued to be active in clinical, teaching and research activities. He has maintained the UCLA Psych REHAB Program which offers the only services at

UCLA dedicated to evidence-based, person-centered and recovery-oriented programs for persons with serious and disabling mental illness. Dr. Liberman is currently in the midst of a research study on recovery from schizophrenia funded by the Nathan Cummings Foundation and a follow-up study of 57 patients who completed a comprehensive "Biobehavioral Evaluation & Plan for Treatment and Rehabilitation."

Beginning in July, 2015, **Judi Smith** was on recall serving as executive director of the UCLA Herb Alpert School of Music. When the regents voted January 21, 2016, to establish the first-ever UC music school, Judi was named interim dean. The new school consists of three departments: music, musicology, and ethnomusicology.

In February, it was announced that the school had received an \$11.7 million gift from the estate of a former UCLA pre-med student with a fondness for classical music. The David Dobrow Trust bequest establishes an endowment that will help ensure the music school's long-term financial secu-David Dobrow attended UCLA from 1946 to 1949 as a premed major. He was a member of the Bruins football team that played in the 1947 Rose Bowl game and went on to earn a medical degree from U.C. San Francisco. He enlisted in the U.S. Air Force and served at Bitburg Air Force Base in Germany where he met Irmgard, a nurse who would later become a physician and his wife.

Dean and vice provost emerita of the UCLA College, Judi Smith relinquished her position as Emeriti Association program committee chair to accept the assignment.

Professor emerita of dance Emma

Lew Thomas reports that since she retired in 1998 she has done as much professional work— teaching, lecturing, directing and choreographing productions, publishing papers, taking two groups of students to Europe, hosting East Germans in LA and the Bay Area, and raising money for the arts and humanities—as when she was active as a professor at UCLA.

Emma Lew has joined the ranks of those creating content that is "born digital." "My Mary" was published in the Bearnstow Journal (Maine) in January. That journal is ONLY distributed on-line.
