The Emeriti Association invites you on Tuesday, Jan. 27, 2026 to a special dinner and a timely, informative UCLA Conversation with Ted Mitchell, President of the American Council on Education, the major coordinating body for the nation's colleges and universities. President Mitchell and his team work closely with Congress, the executive branch, and the private sector to develop policies and innovative practices. He served in the Obama administration as U.S. under secretary of education. President Mitchell previously served as President of Occidental College (1999–2005). At UCLA, he served as Vice Chancellor for External Affairs (1997–1998), Vice Chancellor for Academic Planning and Budget (1996–1997), and Dean, School of Education and Information Studies (1992–1998). He has been a leader in K–12 education. Throughout his career, President Mitchell has worked to create an educational system that serves the goals of excellence, equity, and social justice. He is a current board member of Coursera, Khan Academy, and more. President Mitchell will discuss current higher education issues with Stuart Wolpert, director of UCLA Conversations, followed by an audience Q&A. This program will not be recorded.

The Emeriti and Retirees Associations invite you to our popular annual musical program featuring piano recitals by two extremely gifted students in The UCLA Herb Alpert School of Music, who were selected by their UCLA piano professors. Performing will be Alessio Santolini Raggi, who is studying under Inna Faliks, Professor and Head of the School's Piano Department; and Hongbo Cai, a student from the studio of David Kaplan, Associate Professor and holder of the School's Inaugural Shapiro Family Chair in Piano. Alessio Santolini Raggi, 23, is a multi-award-winning artist based in Los Angeles, working at the intersection of experimental electronic pop and contemporary classical music. He learned piano at age 5, violin at 9, composition at 11, and digital audio production at 15. By 22, he had earned a master's degree in piano, a bachelor's in composition, a second-level master's in piano, and a master's in film and media composition — all with honors — and is currently pursuing an additional master's in piano with Professor Faliks. Alessio has studied at institutions in Italy, Spain, Switzerland and California, and is fluent in five languages: Italian, English, Spanish, French, and German — in addition to classical studies in Latin and Ancient Greek. From New York to Hong Kong, he has participated in a diverse range of events, including solo, chamber and orchestral concerts, discographic recordings, radio and television projects, artistic curations, movie productions, conferences, and film festivals. Alessio has won first prize in a wide variety of national and international music competitions. He released his piano album “Interplay” for Bösendorfer this year, and is currently working on two other electroacoustic albums at Funkhaus, Berlin, planned for release next year.

Hongbo Cai is an interdisciplinary musician, writer, filmmaker, and researcher whose work bridges creative performance practice with critical inquiry into media. A graduate in piano performance from The Juilliard School, he made his Carnegie Hall debut at 21 and, at 22, joined New York University's piano faculty as an adjunct professor. The following year, he appeared with the Orchestra of St. Luke's at Carnegie Hall's Stern Auditorium. He has performed with orchestras including the Shanghai Opera House, Shanghai Philharmonic, Pazardzhik State Symphony Orchestra (Bulgaria), Mikhail Jora Philharmonic (Romania), Florence Philharmonic, New York Youth Orchestra, West New York Chamber Orchestra, Orquestra do Algarve (Portugal), and members of the New York Philharmonic. As a writer-director, his works have been selected by the Venice Biennale College Blend, the Beijing International Short Film Festival, the Toronto International Independent Short Film Festival, and the Clermont-Ferrand Short Film Festival and were presented at New York University's Music Department Colloquium Series. His theater works have been chosen for the Juilliard Risk Lab Residency and the 2025 Community Impact Residency Program for U.S. Emerging Artists.

Both Alessio and Hongbo will perform piano concerts on the University Club's Steinway B piano, located in the Morrison Room, and each will have a short conversation with Stuart Wolpert, director of UCLA Conversations.

We will be joined by Michael Beckerman, the new Dean of The UCLA Herb Alpert School of Music.

Attend "The Myths and Realities of Entitlement Programs in our Aging Nation" at Belmont Village March 11

The UCLA Emeriti and Retirees Associations invite you to an engaging and informative UCLA Conversation with **Fernando Torres-Gil**, Director of UCLA's Center for Policy Research on Aging and UCLA Professor Emeritus of Social Welfare and Public Policy. This program is titled "The Myths and Realities of Entitlement Programs in our Aging

Nation." Professor Torres-Gil is a national expert on aging, health and long-term care, with extensive U.S. and California government experience. President Jimmy Carter appointed him to the Federal Council on Aging; President Bill Clinton appointed him as U.S. Assistant Secretary on Aging in the U.S. Department of Health and Human Services. Professor Torres-Gil organized the 1995 White House Conference on Aging. President Barack Obama appointed him as Vice Chair of the National Council on Disability and Staff Director of the U.S. House Select Committee on Aging. He is a board member of the AARP Foundation.

Professor Torres-Gil will shed light about on-going debates regarding the financial dilemmas facing Social Security and Medicare and what he describes as the scare tactics by both parties about the solutions for sustaining these programs as well as public and private pensions. He will discuss the realities of an aging population and the future of entitlement programs for today's elders and aging baby boomers. He will share lessons from his distinguished career that shed light on the politics of aging. Topics are also expected to include long-term care and the caregiving crisis facing the nation.

This conversation will be led by **Daniel J.B. Mitchell**, Professor Emeritus at UCLA's Anderson Graduate School of Management and UCLA's Luskin School of Public Affairs, who has served on the Emeriti Association's Board of Directors for more than a decade.

UCLA Senior Scholars program enables you to audit UCLA lecture courses

For those who love lifelong learning, the UCLA Senior Scholars enables adults 50 and older to audit courses campus-wide. Senior Scholars audit lectures and do class readings, but do not take tests, write papers, turn in homework assignments or attend discussion sections or labs. Senior Scholars do not receive a grade or academic credit.

Quarterly fees are \$200 for each class, which includes a \$30 administrative fee per course. If you are interested, you may sign up and then contact instructors for permission to attend. Approval to attend any course is subject to instructor consent and classroom space limitations, and does not include seminars or performing art courses.

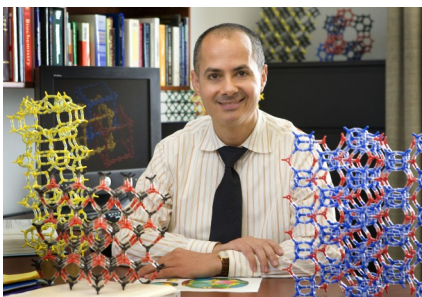

2025 Nobel Prizes: Wins for UCLA and a record-setting year for UC

Omar M. Yaghi, a former UCLA professor of chemistry and biochemistry who is currently the James and Neeltje Tretter Professor of Chemistry at UC Berkeley, was awarded the 2025 Nobel Prize in chemistry. In addition, immunologist Frederick J. "Fred" Ramsdell, who earned his doctorate in microbiology and immunology from UCLA in 1987, was awarded the Nobel Prize in physiology or medicine for his groundbreaking work on the human immune system in 2025, a year in which the [University of California set a world record](#) for the most Nobels awarded to one university system.

During the 2025 ASME Summer Heat Transfer Conference in Colorado, UCLA Samueli School of Engineering hosted a symposium recognizing Professor Vijay Dhir for his extraordinary scientific and professional contributions to the field of thermal and multiphase transport. A Distinguished Professor Emeritus of Mechanical and Aerospace Engineering and the former Dean of the Henry Samueli School of Engineering and Applied Science, Professor Dhir was honored for his pioneering work and decades of leadership in boiling heat transfer, microgravity phenomena, nuclear thermal hydraulics, and energy systems. In Memoriam

Richard E. Dickerson, 93, a giant in structural biology and a Director of UCLA's Molecular Biology Institute

Distinguished Professor Emeritus Richard E. "Dick" Dickerson, a giant in structural biology, passed away on May 14, 2025, at the age of 93. He was preceded in death by his beloved wife, Lola, who passed away one year earlier.

After earning his Ph.D. in Physical Chemistry in 1957, working in the laboratory of Professor William Lipscomb (Nobel Laureate in Chemistry, 1976) at the University of Minnesota and completing a post-doctoral fellowship in the lab of Professor John Kendrew (Nobel Laureate in Chemistry, 1962), Dick set up a lab at the University of Illinois, where he produced the famous "sausage" diagram of myoglobin, the basis for all future representations of atomic structures of proteins from those of Jane Richardson to those of Irving Geis and then to computer images.

In 1963, he moved to the California Institute of Technology in Pasadena, where he continued his work on determining the crystal structure of large molecules. Dick later shifted his focus to the structure of DNA and was among the first investigators to determine the crystal structure of the DNA double-helix.

In 1981, Dick moved his lab to UCLA and served as the Director of the Molecular Biology Institute from 1983-1994. At UCLA, Dick changed his focus to

DNA and determined the first atomic structure of the B form of DNA. Watson was quoted as saying that this structure convinced him for the first time that the [Watson-Crick structure](#) was correct. In 1985, Dick was elected to the National Academy of Sciences and the American Academy of Arts and Sciences.

Dick was a prolific author; in addition to many seminal papers in structural biology he authored multiple textbooks on physical chemistry, general chemistry, biology, protein chemistry, and evolution. Dickerson's energy was also reflected in his non-research writings. In 2005, he wrote [Present at the Flood: How Structural Molecular Biology Came About](#) and in 2009 [a history of the UCLA Molecular Biology Institute, from 1960 to 1978](#). Dick retired in 2004, but never lost his love of learning, turning his passion towards historical French political artwork and lifelong love of opera.

"Dick was so amazingly competent: in experiments, in computer coding, in writing, in lecturing, and even in art," said Professor David Eisenberg. "His collaborations with Irv Geis on artistic representations proteins and DNA alone advanced understanding of biology. Dick thought deeply about evolutionary theory and wrote tracts to attack creationist views."

Kent Wong, 69, immigrant rights champion and former director of UCLA Labor Center

Kent Wong, former director of the [UCLA Labor Center](#) from 1991–2023 and professor of labor studies and Asian American studies, died Oct. 8. He was 69. Wong, a community leader, was renowned across Los Angeles and the nation for his advocacy on labor and immigrant rights. As director of the UCLA Labor Center for 32 years and, more recently, its project director of labor and community partnerships, Wong established the center as a groundbreaking hub for research and leadership development programs that serve workers and immigrants.

Wong wrote and edited several books, including [Asian American Workers Rising](#) and [Revolutionary Nonviolence: Organizing for Freedom](#).

"Kent's tireless leadership and dedication helped place UCLA at the forefront of community engagement, academic research and a push for a worker-centered economy in Los Angeles," said Abel Valenzuela, UCLA's dean of social sciences. "For generations to come, Kent's legacy will continue to endure through this center as a profound reminder of our obligation to support research and policy solutions that advance economic justice for all."

The Edward A. Dickson Award was created by a gift endowment from the late Edward A. Dickson, a Regent of the University of California from 1913 to 1946. The award honors outstanding research, scholarly work, teaching, and/or educational service (e.g. service in professional, University, Academic Senate, emeriti, departmental or editorial posts, or committees) performed by an emeritus or emerita professor since retirement. Each of the UC campuses has received funds that will support one or more awards each year. Nominations for this award should highlight the nominee's distinctive research, scholarly work, and/or educational service since retirement.

The Carole E. Goldberg Award was created in 2014 to honor outstanding service in professional, University, Academic Senate, emeriti, departmental or editorial posts, or committees performed at UCLA by an emeritus or emerita professor since retirement. Nominations for this award should highlight the nominee's distinguished service to UCLA since retirement.
