WARREN OLNEY IV WILL SPEAK AT WINTER DINNER

"From TV News to Public Radio: a Career in Public Affairs" will be the topic of celebrated broadcast journalist Warren Olney's talk at the Emeriti Association's Winter Dinner meeting on Wednesday, February 11, 2015.

Warren Olney IV was named "Best Radio Journalist of the Year" at the Los Angeles Press Club's 2001 Southern California Journalism Awards and received the 2012 Lifetime Achievement Award for his broad achievements in television news and storied career over 20 years on public radio, both locally and nationally. He is the only person to have been twice named "Broadcast Journalist of the Year" by the Society of Professional Journalists, Los Angeles. He is the recipient of Emmy Awards for reporting and anchoring and Golden Mikes for investigative reporting.

He is currently the host and executive producer of *Which Way, LA?* and *To the Point*. Warren was a television news reporter and anchor from 1966 to 1991, working in Washington, DC, Sacramento, and Los Angeles. His interviews, book reviews, and columns have appeared in the *Los Angeles Times*, the *Village Voice*, and *California Journal*. As an actor, he has appeared in numerous feature films including "Crimson Tide", "The Fisher King", and "Higher Learning".

Olney received his B.A. in English, *magna cum laude*, from Amherst College (Massachusetts) and is a member of Phi Beta Kappa. He has four children and five grandchildren. He is married to Marsha Temple, a former attorney at law, now executive Director of the Integrated Recovery Network, a nonprofit helping the homeless mentally ill to find housing, treatment, and jobs.

AFTER LUNCH PROGRAMS

Thursday, March 12, 2015: "Quality of Care and Cancer", presented by UCLA Professor of Medicine and Public Health Patricia Ganz, M.D.

Patricia A. Ganz, M.D., a medical oncologist, has been a member of the faculty of the UCLA David A. Geffen School of Medicine since 1978 and the UCLA School of Public Health since 1992. Since 1993, she has been the Director of Cancer Prevention and Control Research at the Jonsson Comprehensive Cancer Center. In 1999, she was awarded an American Cancer Society Clinical Research Professorship for "Enhancing Patient Outcomes across the Cancer Control Continuum," and in 1999 and 2000, received the Susan G. Komen Foundation Professor of Survivorship Award. Dr. Ganz was elected to the Institute of Medicine, U.S. National Academy of Sciences, in 2007.

Dr. Ganz is a pioneer in the assessment of quality of life in cancer patients and survivors and has focused her clinical and research efforts in the areas of breast cancer and its prevention. At UCLA's Jonsson Comprehensive Cancer Center, she leads the scientific program focused on Patients and Survivors. In 1997, she established the UCLA Family Cancer Registry and Genetic Evaluation Program that patients and survivors, as well as those at high risk for familial/ hereditary cancers.

Thursday, April 9, 2015: "Better and Worse ways of legalizing Cannabis", presented by Professor Mark Kleiman.

The work of Mark Kleiman, Professor of Public Policy in the UCLA School of Public Affairs, focuses on reducing crime and incarceration by substituting swiftness and predictability for recent severity in the criminal justice system generally and in communitycorrections institutions specifically. His recent projects include studies of the HOPE probation system and of the relationship between drug policy and violence in Afghanistan and Mexico.

Professor Kleiman is the author of Marijuana: Costs of Abuse, Costs of Control; of Against Excess: Drug Policy for Results; and of When Brute Force Fails: How to Have Less Crime and Less Punishment, listed by The Economist as one of the "Books of the Year" for 2009. Drugs and Drug Policy: What Everyone Needs to Know (coauthored with Jonathan Caulkins and Angela Hawken) was pub-

lished in July 2011 by Oxford University Press. He edits the Journal of Drug Policy Analysis. Before coming to UCLA in 1995, he taught at Harvard's Kennedy School of Government and the University of Rochester. Outside of academia, he has worked for the U.S. Department of Justice (as Director of Policy and Management Analysis for the Criminal Division), for the City of Boston (as Deputy Director for Management of the Mayor's Office of Management and Budget) and on Capitol Hill (as a legislative assistant to Congressman Les Aspin). He graduated from Haverford College (magna cum laude), majoring in political science, philosophy, and economics) and did his graduate work (M.P.P. and Ph.D.) at the Kennedy School.
